



WAGE ORDER NO. BARMM-04

PROVIDING FOR A MINIMUM WAGE INCREASE IN THE BANGSAMORO AUTONOMOUS REGION IN MUSLIM MINDANAO (BARMM)

WHEREAS, Item jj, Section 2, Article V of Republic Act No. 11054 also known as the "Organic Law for Bangsamoro Autonomous Region in Muslim Mindanao" provides among others, that the Bangsamoro Government shall exercise its authority, over labor employment and occupation.

WHEREAS, Pursuant to Section 18 (c) and (e), Chapter 4, Title IX, Book VI of the Bangsamoro Autonomous Act (BAA) No.13, otherwise known as the "Bangsamoro Administrative Code" and Republic Act (RA) No. 6727, otherwise known as the "Wage Rationalization Act", the Bangsamoro Tripartite Wages and Productivity Board (BTWPPB) is mandated to periodically assess wage rates and conduct continuing studies in determination of the minimum wage applicable in the region or industry;

WHEREAS, pursuant to Section 18 (d), Chapter 4, Title IX, Book VI of BAA No.13, the BTWPPB of the Ministry of Labor and Employment (MOLE) - BARMM is mandated to determine the minimum wage rate in the Bangsamoro Autonomous Region based on its socio-economic indicators as presented during public consultations.

WHEREAS, the current Wage Order No. **BARMM - 03** took effect on **28 February 2024**;

WHEREAS, pursuant to Section 3(A), Rule II of the BTWPPB Guidelines No. 01, Series of 2024 or the Guidelines on Minimum Wage Determination for All Private Sectors including Domestic Workers, in the absence of any petition filed for a minimum wage adjustment, the Board may *motu proprio* initiate wage review;

WHEREAS, after due notice to all stakeholders, the BTWPPB *motu proprio* conducted series of Public Consultations with the Tripartite Sectors BARMM wide:

WHEREAS, after the conduct of the said public consultations, the BTWPPB made the following assessment, to wit:

- That both the EMPLOYERS and WORKERS support a minimum wage increase for all sectors;
- That every province has a different standard of living, hence, it is recommended to have different minimum wage rate;
- That the EMPLOYERS and WORKERS shall continue to develop and improve their policies on non-wage benefits, bonuses and other related incentives;

- e) That all sectors supported the productivity-based scheme on the company level, in a form of income augmentation;
- e) That the BARMM, under the leadership of Interim Chief Minister ABDULRAOOF A. MACACUA intends to primarily increase employment rate in the Bangsamoro Autonomous Region, thus encouraging more investors to come to create more job opportunities and productivity improvement through skills trainings and strategize proper utilization of mineral resources for economic and industrial development;
- f) That the BTWFB urges the National and BARMM Government to further improve the public utilities in BARMM areas, especially energy/power, water systems, irrigation systems, road networks, and peace and order. This is to ensure that businesses will improve and thrive, and to attract new investments; and
- g) That the BARMM Government should enhance the skills/ productivity of our workers/laborers – making them more competent and competitive and to prepare for the influx of new investments. Once all of these are met, the Wage Board is committed to improve further the minimum wage rates in BARMM areas.

WHEREAS, after a thorough review and evaluation of the existing socio-economic conditions in BARMM based on the data dissemination and news conference of the Philippine Statistics Authority (PSA) – BARMM, the following were established:

- a. The average Consumer Price Index (CPI) in the BARMM in 2024 was at 126.01;
- b. The region's average inflation rate was 4.1% in 2024; and
- c. BARMM poverty threshold for an average family size of five (5) in 2021 is in the amount of Php 11,348.00.

NOW, THEREFORE, by virtue of the power and authority vested under R.A. 6727 and Bangsamoro Autonomy Act No. 13, the BTWFB hereby issues this Wage Order.

Section 1. Amount of Increase. The private sector minimum wage earners within the BARMM shall receive a wage increase amounting to FIFTY PESOS (P50.00) per day.

Section 2. New Daily Minimum Wage Rates. The new daily minimum wage rates in BARMM shall be as follows:

Section 3. Basis of Minimum Wage Rates. The minimum wage rates prescribed under this Order shall be for the normal working hours which shall not exceed eight (8) hours of work a day.

Section 4. Covered. The wage increase prescribed herein shall apply to minimum wage earners in the private sector within BARMM, regardless of their position, designation or status and irrespective of the method by which their wages are paid.

This Wage Order shall not cover the following: (a) household or domestic helpers under Republic Act No. 10361 or the Batas Kasambahay; (b) workers of registered Barangay Micro Business Enterprises (BMBEs) with Certificate of Authority pursuant to Republic Act No. 9178; and others authorized by law.

Section 5. Penal Provision. Any person, corporation, trust, firm, partnership, association, or entity which refuses or fails to pay the prescribed increase shall be dealt with pursuant to the provisions of Section 12 of R.A. No. 6727, as amended by R.A. No. 8188.

Section 6. Effectivity. This Wage Order shall take effect after fifteen (15) days from its publication in the Bangsamoro Gazette or in a newspaper of regional circulation within BARMM.


